2. ELIGIBILITY FOR APPOINTMENT OF SENIOR RESIDENTS/JUNIOR RESIDENTS

Senior Residents	MD / MS Degree in the concerned speciality. Diploma candidates will be considered as per the latest existing MCI guidelines. DNB Candidates will be selected as per the latest existing MCI guidelines.

5. **Age:** Candidates should be less than 40years of age (As per MCI Requirement)

6. Reservations:

Rule of Reservations will apply as per Telangana State Govt. Rules in force.

7. Marks scored in the PG theory examination will be the criteria for Selection. The local fresh batch students of Dr. KNRUHS/NTRUHS will be given preference over others. In case more than one candidate is having the same theory marks in that particular batch, date of birth will be taken into consideration. The older person shall get first preference.

8. Those candidates who have done PG as non-local candidates in Andhra Pradesh state and want to join as Senior Residents in Telangana state have to apply with No Objection Certificate (NOC) from Andhra Pradesh DME.

Application Procedure

On the day of interview the candidate should submit an application by downloading the application proforma from the official website of Director, Govt. Medical College, Siddipet (<http://www.gmsiddipet.org/>)

Two sets of attested copies of the following certificates to be enclosed with the application

1. S.S.C. certificate (proof of date of birth)
2. Study certificate from class IV to X and Intermediate
3. MD / MS / DNB / MBBS / M.Sc Degree Certificates
4. MBBS Registration / Registration of PG / DNB degree with Telangana State Medical Council
5. Aadhar Card- Proof of Residence
6. PAN Card
7. Doctors who are working on contract service with the Govt. should produce service certificate.
8. Caste Certificate in case SC / ST / BC. (Certificates issued by competent in case of SC/BC specifying caste and sub - group indicating A / B / C / D / E in case of BC's)
9. Four Passport Size Photographs of the Candidate.
10. Selected candidates should submit their original certificates of Degree and Registration of both MBBS and MD/MS/DNB at the time of reporting which will be retained by the College authority for which custodian certificate will be issued by the college.
11. Candidate once selected and joined and discontinues within one year he/she will not be considered for any future selections.
12. If a candidate wants to leave Senior Residency. He/she should give one month notice, following which only original documents will be returned.
13. All the selected candidates have to submit cancelled cheque with IFSC Code.
14. Accommodation will be provided where ever available.

NOTE:

1. The candidates should bring their original certificates for Verification at the time of interview.
2. Applications not properly filled up or without necessary Enclosures will be summarily rejected.
3. Selection Process:
 - a) The selection will be done by a Selection Committee Constituted by the Director, Government Medical College, Siddipet.
 - b) Total Marks: 100
 - i. 75% of the marks in the qualifying examination
 - ii. 10% marks for possessing additional degree 5 marks for PG Diploma
10 marks for PG Degree
 - c) 15 marks for interview conducted by selection Committee.
4. The decision of the selection committee in all aspects and all respects pertaining to application and its acceptance or rejection as the case may be, the selection (or) otherwise of any candidate shall be final in all respects and binding on all concerned.
